## PRIVACY & SECURITY POLICY

### 1. DEFINITIONS

- 1.1. PMSA shall mean PMISA (Association incorporated under Section 21)

### 2. PRIVACY POLICY

- 2.1. Any information which you provide to PMSA, whether on any forms you complete or through this web site, and any information which PMSA have about you will be regarded by PMSA as personal information and, subject to the Terms and Conditions, be treated as confidential.
- 2.2. No personal information will be disclosed to third parties without the user's permission; however, PMSA may share personal information with business partners.
- 2.3. We do not sell, rent or lease our membership, delegate or advertiser lists to third parties. PMSA shall take all reasonable steps to protect the personal information of users. For the purpose of this clause "personal information" shall be defined as detailed in the Promotion of Access to Information Act 2 of 2002 (POAIA)
- 2.4. PMSA gathers and will be in possession of the following private and personal information of users:
  - 2.4.1. Information provided by the user voluntarily
  - 2.4.2. Information automatically provided (e.g. cookies) - this information is gathered to improve the efficiency of your browsing on the PMSA web site. Cookies are harmless to computer and do not carry viruses.
- 2.5. By using this web site the user consents to the following:
  - 2.5.1. PMSA may use your personal information for communication purposes from time to time. Users may request to be removed from any communication system at any time;
  - 2.5.2. PMSA may use user's information for statistical purposes;
  - 2.5.3. PMSA may use your personal information in the ordinary course of its business and for promotions and marketing.
  - 2.5.4. PMSA retains the copyright in databases of personal information of users; and
